Full Text of BEFI's Circular No. 05/2015 Dt. 04.02.2015

Dear Comrades,

UFBU REVIVES STRIKE PROGRAMME

This refers to our Circular No.03/2015 dated 20th January 2015.

In view of IBA's assurance for expeditious wage settlement and developments following the conciliation dated 05th January 2015, UFBU had put the 4 days' strike from 21st January 2015 on hold. Another round of wage-negotiations was held, in this background, in Mumbai on 03rd instant. After reporting on the discussions in the meetings of the three Sub-Committees on (i) Workmen's service conditions, (ii) Officers' service conditions and (iii) revised medical reimbursement scheme, the most important issue of wage increase came up for discussion. In this matter, IBA persisted with its non-conciliatory and unreasonable stand and, after prolonged discussion, improved its offer by a paltry 0.5%, i.e. from 12.5% to 13.0%; naturally enough, UFBU had no alternative to rejecting the same outright as most inadequate, unjustified and unreasonable.

The negotiations over, UFBU met and, having taken stock of the situation, decided to revive the strike programme and programmes preparatory thereto which is reproduced **OVERLEAF** for your information and implementation.
